Work is underway with the Midlands Engine Programme Director to confirm a forecast budget for the remainder of the year, based upon programmed Midlands Engine activity.

As reported to the last Executive Board, we continue to raise a clear concern that local partner core funding contributions are not yet fully complete. These are a requirement of Government funding. We will continue to work through the Programme Director to escalate this with Chief Executives of each contributing authority whose payment has not yet been received.

Grant letters for the Mental Health programme (£7 million) and ESOL programme (£1million) have now also been received. The tender process for the ESOL programme has been completed and the contracts issued.



### Staffing position

The table below sets out the current position on recruitment of staff for the Midlands Engine Secretariat. Based upon the structures and budgets agreed previously be Executive Board, following recent recruitment processes, eight posts are currently filled.

- **Communications and Marketing Director** following the resignation of the previous post holder, the Programme Director has appointed a consultant on an interim basis.
- Innovation Officer remains vacant.
